[REDACTED] . [REDACTED], male Caucasian, [REDACTED] After being advised of the identity of the interviewing Agent and Task Force Officer as the nature of the interview, [REDACTED] provided the following information:

[REDACTED] initial conversation and mannerisms suggested some degree of possible mental illness or emotional instability. Although [REDACTED] was polite and well mannered.

The basis of this interview was predicated on an email sent to office of the ADIC, FBI, New York Field Office, Criminal Division by former FBI SA [REDACTED] [REDACTED] on July 12, 2019. The email referred to a request that Bureau personnel contact an investigative journalist friend of [REDACTED] MICHAEL MOORE (not the film producer) via [REDACTED] regarding an interview of a purported victim of JEFFREY EPSTEIN victim. The author made phone contact with MOORE and an interview was scheduled at the C-20 office on Tuesday August 27, 2019 for 12:00 PM. MOORE stated that the alleged victim ([REDACTED]) was traveling via bus from Rhode Island to the New York Field Office. The author met with MOORE and [REDACTED] and MOORE stated he would not be present during the scheduled interview.



[REDACTED] stated that he first met EPSTEIN at approximately age four (4) while at the [REDACTED] East Greenwich, Rhode Island. [REDACTED] stated that his family were members of the [REDACTED]. [REDACTED] stated at that time he was raped (sodomized) by his great uncle, [REDACTED] and that EPSTEIN was present and did not touch him. [REDACTED] stated that after he was raped by his great uncle ([REDACTED]), EPSTEIN then spoke with him ([REDACTED]). [REDACTED] stated he did no know the identity of EPSTEIN until some unspecified time in 2016.

[REDACTED] further stated in sum and substance that while on a large luxury ship, that sailed out of the Newport boat show in Newport, Rhode Island (September [REDACTED]), at approximately eight years of age he ([REDACTED]) was subjected to some type of "medical" exam about the yacht by unknown doctor while his great uncle ([REDACTED]) and family member [REDACTED] were present. [REDACTED] went on to describe a bizarre event in which [REDACTED] inserted a tape measure in his ([REDACTED]) rectum. [REDACTED] stated subsequent to the "exam" he was then raped (sodomized) by JEFFREY EPSTEIN as well as former United States President, WILLIAM J. CLINTON, while in a "heavy drug induced state". [REDACTED] also stated the bottoms of his feet and back were

slashed. [REDACTED] further stated also during the said yacht trip multiple unknown male Blacks were engaged in sex acts with unknown female Whites, who had their backs slashed and were bleeding. [REDACTED] also described several infants being killed and their intestines removed as well as other acts of cannibalism. [REDACTED] also stated that former United States President, GEORGE H.W. BUSH (engaged in a sex act with an unknown male Black), former United States Secretary of State, HENRY KISSINGER and businessman GEORGE SOROS were present on the same yacht while all of the aforementioned acts of violence were occurring. [REDACTED] was then asked if he had any injuries or scars as evidence, to which [REDACTED] responded "on my anus". [REDACTED] was unable to provide any supporting or corroborating evidence or the identities of any witnesses to support his claim of victimization. [REDACTED] did provide a handwritten list of his family and extended family members and it was not clear what investigative value, if any the list held. [REDACTED] also stated that his great uncle, [REDACTED] [REDACTED] is in possession of video evidence of his crimes against ([REDACTED]) as well as several "snuff films", that [REDACTED] had watched in the presence of his great uncle ([REDACTED] [REDACTED]).
